

Overseas pension transfers

Most UK pension plan members are able to transfer their benefits to other approved pension schemes. The Finance Act 2004 introduced new rules with regards to transferring pension overseas, including the concepts of recognised overseas pension schemes and qualifying recognised overseas pension schemes (QROPS).

Qualifying recognised overseas pension scheme (QROPS)

The new rules have given rise to the Qualifying Recognised Overseas Pension Scheme which is an investment vehicle that allows existing UK registered pension schemes to be transferred overseas for those individuals residing elsewhere. To qualify as a QROPS, a pension scheme must be officially recognised by the HMRC. A QROPS must be registered as a pension scheme recognised for tax purposes in the country where it is established and must be outside of the UK.
