

Key Information Document (KID) - Capital With-Profits Bond (20)

Purpose

This document provides you with key information about this investment product. It is not marketing material. The information is required by law to help you understand the nature, risks, costs, potential gains and losses of this product and to help you compare it with other products.

Product

The 'Capital With-Profits Bond Plan' is manufactured by LICI UK. Visit https://www.liciuk.com/ or call 0800 068 5712 for more information. The Financial Conduct Authority (FCA) is the competent authority of Life Insurance Corporation of India. This KID was produced on 22 October 2020.

What is this product?

Type

The 'Capital With-Profits Bond Plan' is a single premium endowment policy with a minimum single investment of £5,000 is paid (or £2,000 for follow-up investments), for a guaranteed cash sum at maturity or in the event that you die within the savings period, as well as bonuses dependent on investment performance.

Objectives

- It aims to increase the value of your lump sum investment growing steadily over the medium to long term and to provide a guaranteed cash sum if you die during the savings period or at the end of the savings period.
- You may also receive a share of the profits of LICI UK's with-profits fund, achieved by investing
 pooled contributions with those of other investors in a wide range of investments including
 stocks and shares.
- The bonuses received from the with-profits fund will depend on the performance of the stock market related investments they are invested in, and are not guaranteed. However once awarded, they will not be taken away.

Intended investor

- Individual with a medium to long term investment horizon with a medium tolerance to risk.
- You must be aged between 18 and 59 years at the start of the plan.


Insurance benefits

• No extra benefit other than the guaranteed cash amount plus any bonuses to date.

Further information

- The maturity date is agreed at the start of your plan. The minimum term is 5 years and the maximum is 20 years, with a maximum age at maturity of 74 years.
- The plan is a non-qualifying policy, which means higher and additional tax payers will have a tax liability on the gains made from this investment.
- LICI UK is not entitled to unilaterally terminate this product unless you have misrepresented the facts provided to us.

What are the risks and what could I get in return?



The risk indicator assumes you keep the product for 20 years.



The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you. We have classified this product as 3 out of 7, which is a medium-low risk class. This rates the potential losses from future performance at a medium-low level, and poor market conditions could impact the capacity of LICI UK to pay you. You are guaranteed to be provided your agreed cash sum plus bonuses to date at the maturity date of your plan or when you die. If LICI UK is not able to pay you what is owed, you could lose your entire investment.

Performance Scenarios

This table shows the money you could get back over the next 20 years, under different scenarios, assuming that you invest £10,000. The scenarios shown illustrate how your investment could perform. You can compare them with the scenarios of other products. The scenarios presented are an estimate of future performance based on evidence from the past on how the value of this investment varies and are not an exact indicator. What are the costs?
